ENTRY FORM

Demolition Derby Rules Apply before, during and after the Derby.

The rules and/or regulations set forth herein are designed to provide for the orderly conduct of the derby event and to establish minimum acceptable requirements for such event. These rules shall govern the condition of the event, and by participating in the event, all participants are deemed to have complied with these rules.

No expressed or implied warranty of safety shall result from publications of/or compliance with these rules and/or regulations.

Allen County derby officials shall be empowered to permit minor deviation from any of the specifications herein or impose any further restrictions that, in their opinion, do not alter the minimum acceptable requirements.

Any interpretation or deviation of these rules is left to the discretion of the officials, whose decision is final.

7 p.m. Start Time

Cars and trucks must be signed in and inspected at the track at least one hour prior to show time.
NO EXCEPTIONS!! Gates open at 2:00 p.m. Inspection begins at 5 p.m. Derby starts at 7 P.M.

4 Heats-----Mini-Car Heat-----Mini Trucks-----Consolation Heat----- Truck Heat----- Main Event

1. Entry form to be filled out and returned. There are only 80 spots, and the first 80 paid entry forms received will fill those spots. One entry per person. Officials reserve the right to accept or reject any and all applicants.
2. All persons regardless of age in pit must sign release to be permitted in pit area. Additional pit passes \$15.00.
3. This derby will consist of four individual heats with the last THREE cars running eligible for the MAIN EVENT. Heat qualifiers must drive the same car in the MAIN EVENT that you drove in the HEAT. A consolation heat will run prior to the MAIN EVENT for any cars from the first four heats which did not place but are still running. THREE cars from the consolation heat qualify for the MAIN EVENT. Entry fee for consolation heat is \$15.
4. Entrants of the Demolition Derby are not employees of the promoter nor the sponsoring track, but are considered to be independent contractors.
5. Anyone under the influence of intoxicating beverages or drugs disqualifies the car and the crew of the offending party.
6. A driver will be disqualified if the driver's door comes open during any event.
7. There will be no buddy system or sandbagging. This will result in disqualification. Hits must be aggressive.
8. The Allen County Agricultural Society will not be held responsible for any cars, parts, or personal property before, during or after the show or overnight.
9. No starting fluid allowed in auto during derby.
10. The decision of the judges and the Demolition Derby stewards will be final.
11. I acknowledge by my signature on the Entry Application that I have received and read a copy of these rules as well as the Official Rules of the Allen County Fair Demolition Derby.
